

ORDINANCE NO. 273**AN ORDINANCE TO PROVIDE FOR THE LICENSING OF
ELECTRICIANS.**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD,
COLORADO:

Section 1. (1) The term "Master Electrician" means a person having the necessary qualifications, training, experience and technical knowledge to properly plan, lay out, and supervise the installation and repair of wiring apparatus and equipment for electric light, heat, power and other purposes in accordance with standard rules and regulations governing such work, such as the national electrical code.

(2) The term "J Journeyman Electrician" means a person having the necessary qualifications, training, experience and technical knowledge to wire for, install, and repair electrical apparatus and equipment for lights, heat, power and other purposes, in accordance with standard rules and regulations governing such work.

(3) The term "Electrical Contractor" means any person, firm, copartnership, corporation, association or combination thereof, who undertakes or offers to undertake for another the planning, laying out, supervising, and installing or making of additions, alterations and repairs in the installation of wiring apparatus and equipment for electric light, heat and power. A registered electrical engineer who plans or designs electrical installations shall not be classed as an electrical contractor.

Section 2. No person shall engage in or work at the business, trade or calling of a journeyman electrician or a master electrician within the corporate limits of the Town of Berthoud, Colorado, until he shall have obtained a license as provided in this Ordinance.

Section 3. Any individual, firm, copartnership or corporation may engage in the business as an electrical contractor without an electricians license if all the electrical work performed by such individual, firm, copartnership or corporation is under the direction and control of a licensed master electrician.

Section 4. Any person may work as an apprentice to a licensed electrician but shall not do any electric wiring for or installation of electrical apparatus or equipment for electric light, heat or power except with and under the direct supervision of a licensed electrician.

Section 5. Nothing in this Ordinance shall be construed to require any individual to hold a license before doing electrical work on his own home or place of business. However, all such work must conform to all local, state and national codes and be subject to inspection.

Section 6. No provision of this Ordinance shall in any manner interfere with, hamper, preclude or prohibit the selling, delivering, connecting or repairing of any electrical appliance, if, the connection or repair of said appliance does not necessitate the installation or repair of electrical wiring of the structure where said appliance is connected.

Section 7. (1) Any person desiring a license under the provisions of this Ordinance shall make a written application therefor to the Town Clerk. Said application shall be in the form and shall contain such information as shall be required by the Town Clerk,

(2) Upon filing of such application the Town Clerk shall grant a license to any person who shall hold a valid Master Electrician or Journeyman Electrician license issued by the State of Colorado, upon payment to the Town Clerk of a license fee for one year in such amount as the Board of Trustees may from time to time prescribe.

Section 8. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be fined in a sum not less than \$5.00 nor more than \$50.00, and costs, and each day of violation shall be deemed a separate offense.

Section 9. Ordinance Number 111 of the Town of Berthoud, and all other Ordinances and parts of Ordinances in conflict herewith are hereby repealed, PROVIDED, that all licenses heretofore issued under the terms of said Ordinance No. 111 shall remain valid until they expire under the terms of said Ordinance.

Section 8. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be fined in a sum of not less than \$5.00 nor more than \$50.00, and costs, and each day of violation shall be deemed a separate offense.

Section 9. Ordinance Number 111 of the Town of Berthoud, and all other ordinances and parts of ordinances in conflict herewith are hereby repealed. PROVIDED, that all licenses heretofore issued under the terms of said ordinance Number 111 shall remain valid until they expire under the terms of said ordinance.
