Ordinance No. 257

Making Appropriation For the Fiscal Year Beginning April 1, 1958.

BE IT ORDAINED BY THE BOARD OF TRUSTEES of the Town of Berthoud:

Section 1. That the following named sums for the following named purposes be, and are hereby appropriated to defray the necessary expenses and liabilities of the Town of Berthoud for the fiscal year beginning April 1, 1958.

FIRST, For the water works the sum of \$7,500.00 for repairs, extensions, and current expenses of the water department.

SECOND, For interest and redemption of water bonds, the sum of \$9,764.50.

THIRD, For streets, alleys, ditches and sewers, the sum of \$7,000.00 for the construction and repair of the streets, avenues, alleys, culverts, sidewalks, crosswalks and ditches, and for the repair and incidental expenses of the sewers now constructed or which may be hereafter constructed, or for the lighting of the streets.

FOURTH, For the payment of any liabilities of the Town in connection with the municipal park and recreation grounds, and for the improvements, maintenance and cost of caring for said park and grounds, the sum of \$500.00.

FIFTH, For the payment of any expenses and liabilities of the Town of Berthoud in connection with the police department, the sum of \$1,000.00.

SIXTH, For the payment of any expenses and liabilities of the Town in connection with the cemetery, the sum of \$600.00.

SEVENTH, For the payment of salaries, labor, capital outlay and any other expenses and liabilities of the Town not hereinbefore provided for, the sum of \$19,447.33.

BE IT ORDAINED BY THE BOARD OF TRUSTEES of the Town of Berthoud:	
Section 1. That the following named sums for the following named purposes be, and are hereby appropriated to defray the necessary expenses and liabilities of the Town of Berthoud for the fiscal year beginning April 1, 1958.	
FIRST. For the water works the sum of \$7,500.00 for repairs, extensions, and current expenses of the water department.	
SECOND. For interest and redemption of water bonds, the sum of \$9,764.50.	
THIRD, For streets, alleys, ditches and sewers, the sum of \$7,000.00 for the construction and repair of the streets, avenues, alleys, culverts, sidewalks, crosswalks and ditches, and for the repair and incidental expenses of the sewers now constructed or which may be hereafter constructed, or for the lighting of the streets.	
FOURTH, For the payment of any liabilities of the Town in connection with the municipal park and recreation grounds, and for the improvements, maintenance and cost of caring for said park and grounds, the sum of \$500.00.	
FIFTH, For the payment of any expenses and liabilities of the Town of Berthoud in connection with the police department, the sum of \$1,000.00.	
SIXTH, For the payment of any expenses and liabilities of the Town in connection with the cemetery, the sum of \$600.00.	
SEVENTH, For the payment of salaries, labor, capital outlay and any other expenses and liabilities of the Town not hereinbefore provided for, the sum of \$19,447.33.
