

ORDINANCE NO. 310

ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR  
BEGINNING APRIL 1, 1965, AND ENDING MARCH 31, 1966

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD,  
COLORADO:

Section 1. That out of the monies and revenue to be derived from general taxes levied by the Board of Trustees of the Town of Berthoud on all taxable property within the corporate limits of the Town and from revenue to be derived from gasoline taxes, automobile taxes, licenses, permit fees, water rents, sewer rents, franchise taxes, sale of cemetery lots, and from monies derived from general and miscellaneous revenues during the fiscal year, and from the balance of cash on hand in the general fund of the Town, all of which are estimated to be \$96,296.00, there is hereby appropriated for the fiscal year beginning April 1, 1965, the following amounts for the following purposes, to-wit:

FIRST, there is hereby appropriated the amount of \$14,500.00 for the Berthoud Municipal Water System for the following purposes: repairs, operation, maintenance, extensions, payment of salaries, purchase of water, payment of expenses for production and transmission, payment of construction and distribution, expenses of interest and bond retirement, expenses of service connections, and other miscellaneous expenses.

SECOND; there is hereby appropriated the amount of \$22,642.00 for the Berthoud Municipal Street and Park Department for the following purposes: maintenance of streets, alleys, ditches and sewers, lighting of streets, making of improvements, payment of salaries, repairing, extensions, paving and patching, and general upkeep of street, alleys, ditches and parks, and other miscellaneous expenses.

THIRD, there is hereby appropriated the amount of \$5,200.00 for the Berthoud Cemetery Department for the following purposes: expenses of operation, maintenance, payment of salaries, and other miscellaneous expenses.

FOURTH, there is hereby appropriated the amount of \$10,200.00 for the Berthoud Police Department for the following purposes: maintenance and operation of police vehicle, office supply expenses, salaries, and other miscellaneous expenses.

FIFTH, there is hereby appropriated the amount of \$10,821.00 for Office and Miscellaneous for the following purposes: payment of clerk's salary, office supplies, office utilities, and other miscellaneous expenses.

SIXTH, there is hereby appropriated the amount of \$200.00 for the Berthoud Building Fund.

SEVENTH, there is hereby appropriated the amount of \$19,271.00 for the Interest and Redemption of Water Bonds.

EIGHTH, there is hereby appropriated the amount of \$6,485.00 for the Interest and Redemption of Sewer Revenue Bonds.

NINTH, there is hereby appropriated the amount of \$4,667.00 for the Berthoud Sanitation Department for the following purposes: operation, maintenance, salaries, repairs, and other miscellaneous expenses.

TENTH, there is hereby appropriated the amount of \$2,310.00 for the Sewer Revenue Bond Reserve Fund.

Section 2. The Board of Trustees of the Town of Berthoud herewith finds, determines and designates that this Ordinance is necessary for the immediate preservation of the public peace, health and safety and whereas in the opinion of the Board of Trustees, an emergency exists, this Ordinance shall take effect and be in force immediately after its final passage, adoption and publication.


This Ordinance was passed by the Board of Trustees of the Town of Berthoud at its regular meeting held Tuesday, April 13, 1965.
