

AN ORDINANCE APPROVING THE ANNEXATION OF CERTAIN TERRITORY TO THE TOWN OF BERTHOUD, COUNTY OF LARIMER, STATE OF COLORADO, TO BE KNOWN AND DESIGNATED AS LEWIS SECOND ADDITION TO THE TOWN OF BERTHOUD, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, COLORADO:

Section 1.

That a Petition for Annexation together with seven copies of a Plat of said territory as required by law were filed with the Board of Trustees July 16, 1985, by the owners of one hundred percent (100%) of the area of the territory hereinafter described and the Petition for Annexation contains signatures of one hundred percent (100%) of the landowners. That the Trustees by motion at their regular meeting held on July 16, 1985, accepted said Petition and found that the Petition substantially complied with C.R.S. 31-12-105 and 31-12-107. The Board of Trustees has determined that an election is not required under C.R.S. 31-12-107 as provided in C.R.S. 31-12-111. The Board of Trustees has determined that additional terms and conditions were not to be imposed and that the Petition was signed by owners of 100% of the property proposed to be annexed, exclusive of streets and alleys. Therefor, in accordance with C.R.S. 31-12-107, the Town Board determined that an ordinance to annex such territory to the municipality should be adopted.

Section 2.

That the annexation to the Town of Berthoud of the following described territory, to be known and designated as Lewis Second Addition to the Town of Berthoud, is hereby approved:

That portion of the East one half of the Southwest one quarter of Section 23, Township 4 North, Range 69 West of the 6th Principal Meridian, County of Larimer, State of Colorado being more particularly described as follows:

Considering the East-West centerline of said Section 23 as bearing North 89°57'05" West and with all bearings contained herein relative thereto.

Commencing at the South One Quarter corner of said Section 23.

Thence along the North-South centerline of said Section 23 North 00°08'19" East 1610.81 feet to the Southeast Corner Hillsdale Sundivision according to the Plat on file in the office of the Clerk and Recorder of said County;

Thence alone the South line of said Hillsdale Sundivision, North 86°16'22" West 6.01 feet to the TRUE POINT OF BEGINNING.

Thence continuining alone said South line North 86°16'22" West 1318.86 feet to the Southwest corner of said Hillsdale Sundivision. Said corner being a point on the West line of the East one half of the Southwest One Quarter of said Section 23;

Thence along said West line South 00°10'48" West 1696.93 feet to the Southwest corner of the East one half of the Southwest One Quarter of said Section 23;

Thence along the South line of said Southwest one quarter South 90°00'00" East 1317.50 feet;

Thence departing from said South line North 00°08'19" East 1611.20 feet to the TRUE POINT OF BEGINNING.


The above described parcel contains 50.01 acres more or less, and shall be zoned as set forth on the Exhibits
