

ORDINANCE NO. 616

AN ORDINANCE SETTING FORTH THE MINIMUM FINE SCHEDULE AND APPEARANCE REQUIREMENTS FOR VIOLATIONS TRIED IN THE MUNICIPAL COURT FOR THE TOWN OF BERTHOUD, COUNTY OF LARIMER, STATE OF COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER COUNTY, COLORADO

Section 1.

WHEREAS the Town of Berthoud has set forth below the minimum fine schedule and appearance requirements for violations tried before the Berthoud Municipal Court pursuant to Colorado Revised Statutes 13-10-113.

Section 2.

The minimum fine schedule and appearance requirements for the Municipal Court of the Town of Berthoud, State of Colorado are as follows:

All accidents require a mandatory court appearance (MCA).

The Clerk's office of the Court may accept the fines established below. No fine will be accepted until the defendant executes an appearance, plea of Guilty and Waiver.

NOTE: 1. All second offenses within the twelve (12) month period preceding the date of the subject Summons and Complaint shall have the minimum fine increased by Fifty Percent (50%);

2. All third offenses within the twelve (12) month period preceding the date of the Summons and Complaint, requires a mandatory court appearance (MCA); and,

3. Two or more separate charges in one Summons and Complaint requires a mandatory court appearance (MCA) for the person so charged.

If a municipal violation is not listed herein, an appearance before the Court is mandatory. An appearance is mandatory if, in the opinion of the officer issuing the summons and complaint or the chief of police, there are aggravating circumstances which should, in the interests of justice, be brought to the attention of the court.


Section 3. - Repeal


Section 4. Emergency Clause
