

ORDINANCE NO. 610

AN ORDINANCE REGULATING PARKING ON THE STREETS WITHIN THE LIMITS OF THE TOWN OF BERTHOUD, LARIMER, COUNTY, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER COUNTY, COLORADO:

Section 1. Definitions:

The definitions of words used herein shall be controlled by the definitions of those words as set forth in the 1977 Model Traffic Code as adopted by the Town of Berthoud.

Section 2. Prohibited Parking:

a. Unless more specific prohibitions apply it shall be unlawful for a trailer, semitrailer, truck with three (3) axles or more, truck twenty-five (25) feet in length bumper to bumper inclusive, truck-tractor, bus, trailer coach, mobile home, or unlicensed vehicle or a portion thereof to be parked or stand upon the streets and alleys within the corporate limits of the Town of Berthoud, whether such vehicle be attended or unattended, for more than two (2) hours.

b. The provisions of this section shall not apply to these vehicles when they are parked within an area zoned either as M-1 or M-2 districts for more than forty-eight (48) hours.

Section 3. Permits For Extended Parking:

Extended parking of vehicles for more than two (2) hours or forty-eight (48) hours, as applicable, may be permitted pursuant to a permit issued by the Town. Such permits shall be issued only to the owner or regular driver of such vehicle and shall not be transferred or assigned to another owner, driver, or location. The duration of the initial permit shall not exceed fourteen (14) days and may be renewed for a second period not to exceed fourteen (14) days. The permits may be issued where the parking of the vehicle will not adversely affect the safety of other vehicles using the rights of way within the Town or where the use would result in a commercial use of an area not zoned commercially.

Section 4. Penalties:

Parking of vehicles in violation of the provisions of this ordinance shall be unlawful and the following penalty shall apply.

Every person convicted of a violation of any provision stated or adopted in this ordinance shall be punished by a fine not exceeding THREE HUNDRED AND 00/100 DOLLARS (\$300.00). Each period of time during which the prohibited act continues, as described herein, shall constitute a separate violation.

Section 5. Effective Date:

The Board of Trustees of the town of Berthoud herewith finds, determines, and designates that this Ordinance shall take effect and be in force thirty (30) days after publication.

This Ordinance was introduced and read and a public hearing set for April 14, 1987 by the Board of Trustees of the town of Berthoud at its meeting held this 24th day of March, 1987. After a public hearing, this Ordinance was read, passed, and ordered published by the Board of Trustees at its meeting this 14th day of April, 1987.
