

ORDINANCE NO. 868

AN ORDINANCE AMENDING ORDINANCE NO. 635 AND REPEALING ORDINANCE NO. 843 OF THE MUNICIPAL CODE OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

WHEREAS, the Board of Trustees of the Town of Berthoud has reviewed the existing monthly water and wastewater rates and has determined that the income to be derived therefrom will be inadequate to pay the operational costs, maintenance and bonded indebtedness.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1.

Section 2 of Ordinance No. 635 is amended to read:

a. The following service charges plus the charge for each 1,000 gallons of water provided to the tap shall be payable monthly by water consumers located inside and outside the corporate limits of the Town of Berthoud:

b. The following wastewater service charge plus the charge for each 1,000 gallons of sewage shall be payable monthly. The Town shall annually use the best measurements available to determine the average monthly sewage useage for each customer for whom wastewater service is provided by the Town of Berthoud. The Town shall, where available, average the water useage for each customer based upon that customer's water useage for the months of January and February and use that average provided it accurately reflects the customer's useage of the wastewater treatment system during the entire year.

Section 2. Effective Date.

The Board of Trustees of the Town of Berthoud herewith finds, determines and designates that this Ordinance shall take effect and be in force thirty (30) days after publication to be operational for billing purposes for the December, 2000 usage which will be indicated on the January, 2001 billing.

At its meeting October 24, 2000, a public hearing was set by the Board of Trustees of the Town of Berthoud for its meeting held on the 14th day of November, 2000. After the public hearing, the Ordinance was read, passed and ordered published by the Board of Trustees at its meeting this 14th day of November, 2000.
