

AN ORDINANCE AUTHORIZING THE EXPENDITURE OF FUNDS IN EXCESS OF THE 1999 BUDGET

BE IT ORDAINED BY THE BOARD OF TRUSTEES FOR THE TOWN OF BERTHOUD, COLORADO, LARIMER and WELD COUNTIES, COLORADO THAT;

Section 1. WHEREAS, during 1999, the Town of Berthoud determined the Wastewater Fund did not allocate adequate funds to the operating costs; and

The Board of Trustees hereby designates \$13,735 of unappropriated revenue be applied to the operations for the digester; and

Section 2. WHEREAS, during 1999, the Town of Berthoud determined the Open Space Fund did not allocate adequate funds to the operating costs; and

The Board of Trustees hereby designates \$105,640 of unappropriated revenue be applied to the operations for professional services; and

Section 3. WHEREAS, during 1999, the Town of Berthoud determined the Debt Service Fund did not allocate adequate funds to the operating costs; and

The Board of Trustees, hereby designates \$25 of unappropriated revenue be applied to the operating costs for bank services; and

Section 4. WHEREAS, during 1999, the Town of Berthoud determined that the Wastewater 1997 Bond did not allocate adequate funds to the operating costs; and

The Board of Trustees, hereby designates \$318,186 of unappropriated revenue be applied to the operating costs for the Wastewater 1997 Bond; and

Section 5. WHEREAS, during 1999, the Town of Berthoud determined the Conservation Trust Fund did not allocate adequate funds to the operating costs; and

The Board of Trustees, hereby designates \$24,597 of unappropriated revenue be applied to the operating costs for the Conservation Trust Fund; and

Section 6. WHEREAS, during 1999, the Town of Berthoud determined the Park Development Fund did not allocate adequate funds to the operating costs; and

The Board of Trustees, hereby designates \$1,210 of unappropriated revenue be applied to the operating costs for the Park Development Fund; and

WHEREAS, the Board of Trustees determines and designates that these expenditures could not have been accurately forecast at the time the 1999 budget was drafted and that these expenditures were necessary for the immediate preservation of the public health and safety; and


WHEREAS, in the opinion of the Board of Trustees an emergency exists, which jeopardizes the fiscal welfare of the Town and would affect the health and safety of its citizens. This Ordinance shall take effect and be in force upon its final passage and adoption.

At the meeting held on December 14, 1999, the Board of Trustees voted to enact this Ordinance.
