

ORDINANCE NO. 969

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NUMBER 956 OF THE MUNICIPAL CODE OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1. Section 2 of Ordinance Number 956 shall be amended to read as follows:

Section 2. Monthly Volume Charges:

The monthly volume charges to usage for Multi-Family, Educational, Commercial and Residential shall be increased as follows:

First 24,000 gallons @ \$2.09 per thousand

Over 24,000 gallons, \$4.18 per thousand

Over 60,000 gallons, \$4.18 per thousand.

1-1/2 Inch Tap – (Rate Table 123)

First 120,000 gallons @ \$2.09 per thousand

Over 120,000 gallons, \$4.18 per thousand

2-Inch Tap – (Rate Table 124)

First 192,000 gallons @ \$2.09 per thousand

Over 192,000 gallons, \$4.18 per thousand

4-Inch Tap – (Rate Table 126)

First 600,000 gallons @ \$2.09 per thousand

Section 2 Emergency Clause.

The Board of Trustees has determined that reduction in usage fees are appropriate where they will allow the Town to comply with the mandates of the bond covenants and not over fund this enterprise. An emergency therefore exists justifying the passage of this Ordinance to take effect and be in force immediately upon passage. The fees set forth in this Ordinance shall be effective for all September, 2003 billings.

At the regular meeting of the Board of Trustees, this Ordinance was read, passed and ordered published this 26th day of August, 2003 by a vote of 7 in favor and 0 opposed.
