

ORDINANCE NO. 1057

AN ORDINANCE APPROVING THE ANNEXATION AND ZONING OF LAND TO THE TOWN OF BERTHOUD, COUNTY OF LARIMER, STATE OF COLORADO, TO BE KNOWN AND DESIGNATED AS THE BROWN FARM ANNEXATION TO THE TOWN OF BERTHOUD, COLORADO

WHEREAS, a Petition for Annexation together with seven copies of a Plat of said land as required by ordinance were filed with the Town of Berthoud by the owners of one hundred percent (100%) of the area of the land hereinafter described; and,

WHEREAS, the Board of Trustees by motion at its regular meeting accepted said Petition and found that the Petition substantially complied with the statutory requirements set forth in Sections 31-12-104, 31-12-105 and 31-12-107, C.R.S.; and,

WHEREAS, the Board of Trustees has determined that an election is not required under Section 31-12-107(2), C.R.S., as provided in Section 31-12-111, C.R.S.; and,

WHEREAS, the Board of Trustees has determined that additional terms and conditions were not to be imposed and that the Petition was signed by owners of one hundred percent (100%) of the property proposed to be annexed, exclusive of streets and alleys. Therefore, in accordance with Section 31-12-107, C.R.S., the Board of Trustees of the Town of Berthoud has determined that an ordinance to annex such land to the municipality should be considered.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO:

Section 1.

The land described on Exhibit "A" attached hereto and incorporated herein by reference is hereby annexed and shall be known and described as the Brown Farm Annexation to the Town of Berthoud:

The parcel contains approximately 139.374 acres more or less, and shall be zoned T-Transitional.

Section 2. Effective Date:


The Board of Trustees of the Town of Berthoud herewith finds, determines and designates that this Ordinance shall take effect and be in force 30 days after publication.

EXHIBIT "A"
LEGAL DESCRIPTION
Brown Farm Annexation

A plat of a parcel of land in the TOWN OF BERTHOUD, Colorado, located in the Southeast Quarter (SE1/4) of Section Ten (10) and the Southwest Quarter of Section Eleven (11) and the West Half (W1/2) of Section Fourteen (14) and the East Half (E1/2) of Section Fifteen (15), all in Township Four North (T.4N.), Range Sixty-nine West (R.69W.) of the Sixth Principal Meridian (6th P.M.) and being more particularly described as follows:

COMMENCING at the West Quarter corner of said Section 11 and assuming the West line of said SW1/4 of Section 11 as bearing South 00°15'09" East being a Grid Bearing of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/92, a distance of 2649.26 feet with all bearings contained herein relative thereto;

THENCE South 00°15'09" East along the West line of the SW1/4 of said Section 11 a distance of 915.81 feet to a line parallel with and 30.00 feet Southeasterly of, as measured at a right angle to, the existing centerline of the Handy Ditch and said point being the **POINT OF BEGINNING**;

The following five (5) courses and distances are along a line parallel with and 30.00 feet Southeasterly of, as measured at a right angle to, the existing centerline of the Handy Ditch:

THENCE North 67°46'24" East a distance of 351.43 feet;

THENCE North 73°53'14" East a distance of 309.07 feet;

THENCE North 67°23'50" East a distance of 246.84 feet;

THENCE North 65°00'08" East a distance of 331.36 feet;

THENCE North 70°07'22" East a distance of 192.59 feet to the Westerly line of The Trails at Sugar Creek Annexation as recorded _____, 2006 at Reception No. _____ of the records of Larimer County Clerk and Recorder (LCCR);

The following nine (9) courses and distances are along the Westerly lines of The Trails at Sugar Creek Annexation:

THENCE South 00°01'54" West a distance of 1590.28 feet;

 THENCE North 89°44'18" East along said parallel line a distance of 312.41 feet
 to the Westerly line of The Trails at Sugar Creek Annexation;
 THENCE South 00°25'39" East along the said Westerly line a distance of 30.00
 feet to the Southwest corner of The Trails at Sugar Creek Annexation and said
 point also being the Northwest corner of Northeast Addition Annexation;
 THENCE South 00°23'51" East along the West line of Northeast Addition
 Annexation a distance of 30.00 feet to a line which is parallel with and 30.00
 feet Southerly of, as measured at right angles to, the South line of said NW1/4
 of Section 14;
 THENCE South 89°44'18" West along said parallel line a distance of 1298.80
 feet to a line which is parallel with and 30.00 feet Easterly of, as measured at
 right angles to, the West line of said SW1/4 of Section 14;
 THENCE South 89°41'50" West a distance of 60.00 feet to a line which is parallel
 with and 30.00 feet Westerly of, as measured at right angles to, the West line of
 said SW1/4 of Section 14;
 THENCE North 00°04'14" West a distance of 29.49 feet to the South line of said
 NE1/4 of Section 15 and to the Westerly ROW line of County Road No. 17
 (CR17) as recorded September 3, 1970 in Book 1440 at Page 935 of the Larimer
 County Clerk and Records office;
 The following seven (7) courses and distances are along said Easterly ROW line
 of CR17 as recorded September 3, 1970 in Book 1440 at Page 935 of the
 Larimer County Clerk and Records office;
 THENCE North 00°25'08" West a distance of 289.22 feet to a Point of Curvature
 (PC);
 THENCE along the arc of a curve concave to the Southeast a distance of 514.87
 feet, said curve has a Radius of 1462.50 feet, a Delta of 20°10'15" and is
 subtended by a Chord bearing North 09°39'59" East a distance of 512.21 feet to
 a Point of Tangency (PT);
 THENCE North 19°45'07" East a distance of 35.94 feet to a PC;
 THENCE along the arc of a curve concave to the West a distance of 779.77 feet,
 said curve has a Radius of 1607.10 feet, a Delta of 27°48'00" and is subtended
 by a Chord bearing North 05°51'07" East a distance of 772.14 feet to a PT;
 THENCE North 08°02'53" West a distance of 1193.09 feet to a PC;
 THENCE along the arc of a curve concave to the East a distance of 397.06 feet,
 said curve has a Radius of 2895.00 feet, a Delta of 07°51'30" and is subtended
 by a Chord bearing North 04°07'08" West a distance of 396.75 feet to a PT;
 THENCE North 00°11'23" West a distance of 1205.64 feet;
 THENCE North 67°46'24" East a distance of 33.44 feet to the POINT OF
 BEGINNING.

Said parcel of land contains 139.374 acres, more or less (±), and is subject to
 any rights-of-way or other easements of record or as now existing on said
 described parcel of land.
