

ORDINANCE NO. 1197

AN ORDINANCE AMENDING THE ZONING MAP OF THE TOWN OF
BERTHOUD TO ESTABLISH THE ZONING OF PROPERTY KNOWN AS THE
"HOIME DEVELOPMENT ANNEXATION SERIALS 1 AND 2" NEWLY
ANNEXED TO THE TOWN OF BERTHOUD

WHEREAS, certain property known as the "HOIME DEVELOPMENT ANNEXATION SERIALS 1 AND 2" has been annexed to the Town of Berthoud by Ordinance No. 1195 and 1196 passed, adopted and approved the 26th day of May 2015; and,

WHEREAS, C.R.S. 31-12-115 requires that newly annexed property be zoned within 90 days of the effective date of the annexation ordinance; and,

WHEREAS, the Planning Commission has considered the zoning request and has recommended that such newly annexed property be zoned to accommodate residential uses; and

WHEREAS, notice has been published as required by law and a public hearing was conducted,

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD:

Section 1. The official zoning map of the Town of Berthoud shall be amended by the inclusion of the property hereinafter described and which property is commonly known as the "HOIME DEVELOPMENT ANNEXATION SERIALS 1 AND 2".

Section 2. The property is more fully described in the property description attached hereto as Exhibit "A" and made part of this Ordinance by this reference.

Section 3. The above described property known as the "HOIME DEVELOPMENT ANNEXATION SERIALS 1 AND 2" is hereby zoned "R-1 Single-Family".

Section 4. Interpretation. This Ordinance shall be so interpreted and construed to effectuate its general purpose.

Section 5. Publication. The Town Clerk shall certify to the passage of this Ordinance, and cause its contents to be published and shall cause the appropriate change to be made to the official Berthoud Zoning Map.

EXHIBIT A

A portion of the northwest quarter of Section 11, Township 4 North, Range 69 West of the 6th Principal Meridian, more particularly described as follows:

Considering the west line of the northwest quarter of said Section 11 as bearing North 00° 57'23" East with all bearings contained herein relative thereto:

Commencing at the west quarter corner of said Section 11; then South 89°15'08" East along the south line of the northwest quarter of Section 11 a distance of 1230.64 feet; thence North 00° 57'23" East parallel with the west line of the northwest quarter of Section 11 a distance of 30.00 feet to the Point of Beginning; thence North 00° 57'23" East a distance of 800.00 feet; thence South 89°15'08" East parallel with the south line of the northwest quarter of Section 11 a distance of 270.00 feet; thence South 00° 57'23" West a distance of 800.00 feet; thence North 89° 15'08" West along a line parallel to and 30.00 feet north of the south line of the northwest quarter of Section 11 a distance of 270.00 feet to the Point of Beginning; Including any portion of described property lying within County Road No. 1OE, County of Larimer, State of Colorado.
