

ORDINANCE NO. 1155

AN ORDINANCE OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO ADOPTING SURCHARGES TO BE ASSESSED FOR MODEL TRAFFIC CODE VIOLATIONS, INCREASING FEES CHARGED FOR SERVICES PROVIDED BY THE BERTHOUD POLICE DEPARTMENT AND ESTABLISHING A BONDING FEE

WHEREAS, the Berthoud Police Department wishes to implement surcharges to be assessed for traffic violations; and,

WHEREAS, the Berthoud Police Department wishes to increase the fees charged for certain services performed by the Berthoud Police Department,

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO THAT:

Section 1:

- (1) Surcharges, as outlined on the attached Exhibit A, will be assessed for drivers convicted of certain traffic violations within Berthoud town limits.
- (2) Revenue from the payment of these surcharges will be used to fund an investigative service called "Leads-on-Line" which is used to search for stolen items that are pawned or sold on the internet.
- (3) Revenue from the payment of these surcharges may also be used for maintenance and training in Police Department Policy.

Section 2:

Fees for services performed by the Berthoud Police Department shall be as follows:

- (1) Police Reports - \$3.00 per report for initial report, \$.50 per page for supplemental reports
- (2) Fingerprints -
Resident - \$10.00 per person for the first card, \$5.00 for each additional card
Non-resident - \$15.00 per person for the first card, \$5.00 for each additional card
- (3) Individual Background Check - \$8.00 per person
- (4) Sex Offender Registration - \$20.00 – includes fingerprints and photos
- (5) Vin Inspections – Resident - \$15.00 per vehicle
Non-resident - \$20.00 per vehicle
- (6) Bonding Fee - \$45.00 per bond (misdemeanor, petty offense and municipal bonds only).

Section 3: Effective Date.

The Board of Trustees of the Town of Berthoud herewith finds, determines and designates that this Ordinance shall take effect and be in force thirty (30) days after publication.

At its meeting on the 26th day of February 2013 this Ordinance was read, passed and ordered published by the Board of Trustees.
