RESOLUTION ADOPTING FEE SCHEDULE FOR BERTHOUD MEDICAL MARIJUANA CODE

WHEREAS, the Town of Berthoud has recently adopted by reference the Berthoud Medical Marijuana Code; and

WHEREAS, the Berthoud Medical Marijuana Code requires certain business and individuals within the Town to pay registration, license, use, transaction and or certain other fees; and


WHEREAS, the Berthoud Medical Marijuana Code at section 6(c) delegates to the Town Board the authority to determine the number, nature and amount applicable fees by Resolution;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. That any application for a medical marijuana business permit in the Town of Berthoud shall be accompanied by the fees as set forth in the attached and incorporated Medical Marijuana Schedule of Fees.
2. That any all fees associated with ownership and operation of a medical marijuana business, or the provision of services to a patient with a debilitating medical condition by a primary caregiver, are hereby set forth in the attached and incorporated Medical Marijuana Schedule of Fees.
3. That all transactional fees required in the attached and incorporated Medical Marijuana Schedule of Fees shall be paid to the Town no later than the fifth (5th) day of each calendar month.


