

RESOLUTION NO.30-01

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO THAT:

1. At the regular meeting of the Board of Trustees on Nov. 6, 2001, the annexation petition for Yeager 3rd Annexation was submitted to the Board of Trustees by the Clerk as a communication pursuant to Section 31-12-107(1)(f), C.R.S. The location of the property is described on Exhibit "A" attached hereto and incorporated herein by reference.
2. The Board of Trustees has reviewed the petition and finds that the requirements set forth in Section 31-12-107(1)(f), C.R.S. have been substantially complied with.
3. Pursuant to Section 31-12-108(1), C.R.S., the Board of Trustees hereby sets the date for the hearing on the annexation petition for Dec.11, 2001 at 7:30 P.M. in the Town of Berthoud Board Room located at 328 Massachusetts Avenue, Berthoud, Colorado. Notice of this hearing is to be published.
4. The purpose of this hearing shall be to determine whether the area proposed to be annexed meets the applicable requirements of Sections 31-12-104 and 31-12-105, C.R.S. and is eligible for annexation.
5. In the event the Board of Trustees finds that the statutory prerequisites for annexation have been met the Board will hold a public hearing on the ordinance annexing this property.

This resolution was passed by a vote of 5 in favor and 0 opposed at the meeting of the Board of Trustees on the 6th day of Nov., 2001.

That portion of the South Half of Section 22, Township 4 North, Range 69 West of the 6th P.M., Larimer County, Colorado, described as follows:

Beginning at the Northwest corner of the Northeast Quarter of the Southwest Quarter of said Section 22; thence along the North line of said South Half of Section 22 North $89^{\circ}03'17''$ East 1352.04 feet to the East right-of-way line of U.S. Highway 287; thence along said right-of-way line South $00^{\circ}10'13''$ East 1324.11 to the Easterly prolongation of the South line of said Northeast Quarter of the Southwest Quarter of Section 22; thence along said prolongation and South line South $89^{\circ}05'49''$ West 1353.38 feet to the Southwest corner of said Northeast Quarter of the Southwest Quarter of Section 22; thence along the West line of said Northeast Quarter of the Southwest Quarter North $00^{\circ}06'42''$ West 1323.13 feet to the Point of Beginning.
