

RESOLUTION NO. 7-99

A RESOLUTION AMENDING RESOLUTION NUMBER 5-99

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD, LARIMER AND WELD COUNTIES, COLORADO THAT:

1. At the regular meeting of the Board of Trustees on April 6, 1999, the annexation petition for Matthews Farm 3rd Annexation was submitted to the Board of Trustees by the Clerk as a communication pursuant to Section 31-12-107(1)(f), C.R.S. The location of the property is described on Exhibit "A" attached hereto and incorporated herein by reference.
2. The Board of Trustees has reviewed the petition and finds that the requirements set forth in Section 31-12-107(1)(f), C.R.S. have been substantially complied with.
3. Pursuant to Section 31-12-108(1), C.R.S., the Board of Trustees hereby sets the date for the hearing on the annexation petition for May 11, 1999 at 7:30 P.M. in the Town of Berthoud Board Room located at 328 Massachusetts Avenue, Berthoud, Colorado. Notice of this hearing is to be published.
4. The purpose of this hearing shall be to determine whether the area proposed to be annexed meets the applicable requirements of Sections 31-12-104 and 31-12-105, C.R.S. and is eligible for annexation.
5. In the event the Board of Trustees finds that the statutory prerequisites for annexation have been met the Board will hold a public hearing on the ordinance annexing this property.

This resolution was passed by a vote of 6 in favor and 0 opposed at the meeting of the Board of Trustees on the 6th day of April, 1999.

LAND DESCRIPTION
MATTHEWS FARM 3rd ANNEXATION

Those portions of Sections 15 and 22, Township 4 North, Range 69
West of the 6th P.M., Larimer County, Colorado, described as
follows:

Considering the East line of the Southwest Quarter of Section 15 as
bearing North 00°28'14" West and with all bearings contained
herein relative thereto.

Commencing at the South Quarter Corner of said Section 15; thence
South 34°24'14" East, a distance of 35.83 feet to the Southwest
Corner of MATTHEW'S FARM SECOND ANNEXATION, to the Town of
Berthoud, said point also being the True Point of Beginning; thence
along the East line of the 40.00 foot County Road as described in
Deed recorded in Book 512 at Page 451, records of said County North
00°28'14" West, a distance of 3342.65 feet to the Easterly
prolongation of the North line of the South Half of the South Half
of the Northwest Quarter of said Section 15; thence along said
prolongation and North line South 89°00'55" West, a distance of
500.00 feet; thence South 00°28'14" East, a distance of 1984.01
feet to the South line of the North Half of the Southwest Quarter
of Section 15; thence along said South line North 88°50'09" East,
a distance of 460.00 feet to the West line of said 40.00 foot
County Road; thence along said West line South 00°28'14" East, a
distance of 1360.29 feet to the South right-of-way line of Highway
287; thence along said South right-of-way line North 88°43'48"
East, a distance of 40.00 feet to the True Point of Beginning.
