

EXPLANATION OF WATER WASTEWATER SYSTEM CONNECTION FEES

RAW WATER CONTRIBUTION FEES

Raw water contribution fees are used to purchase raw water on a permanent basis for treatment and delivery to the tap. This fee is calculated to insure the Town's ability to deliver up to one acre foot of water to each tap in the system each year.

WATER PLANT INVESTMENT FEES

Water plant investment fees are used to purchase additional treatment capacity in the Town of Berthoud's water treatment facility. Each current tap holder has paid for a portion of the plant's treatment capacity. Water plant investment fees pay for plant expansion when necessary to provide treatment capacity for all water taps. This fee is calculated by dividing the value of the treatment facility by the number of current water taps.

WASTEWATER PLANT INVESTMENT FEES

Wastewater plant investment fees are used to purchase additional treatment capacity in the Town of Berthoud's wastewater treatment facility. Each current tap holder has paid for a portion of the plant's treatment capacity. Wastewater plant investment fees pay for plant expansion when necessary to provide treatment capacity for all taps.

Connection fees are recalculated periodically and are subject to adjustment. The fees are set as low as they can be and still fund the purposes for which they are intended. Because the Town of Berthoud's water and wastewater facilities are established enterprises, connection fees can only be used for the purposes they are intended in the water and wastewater budget and no other.
