A RESOLUTION ESTABLISHING THE FOLLOWING FOUR LOTS, PERPETUAL CARE AND ADDITIONAL SERVICES.

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BERTHOUD THAT PURSUANT TO CHAPTER 22.2 OF THE MUNICIPAL CODE OF THE TOWN OF BERTHOUD THE FOLLOWING FEES SHALL BE IN FORCE AND EFFECT UPON ENACTMENT.

Section 1. Definitions Of Applicable Terms As Used In Chapter 22

a. Resident - anyone living or dying within the corporate limits of the Town of Berthoud. The spouse of the resident shall also be included as shall the children and parents of the residents. In the event an individual who would have been previously classified as a resident loses his status as a resident he may apply to the Board of Trustees or its designated representative for reclassification as a resident. The reclassification shall be considered if the loss of residency was due to required medical treatments or health and residential care considerations which necessitated moving from the Town of Berthoud.

Section 2. Fees

a. Resident Infant:

1. \$100.00 per lot.
2. \$100.00 per opening and closing.
3. \$100.00 for perpetual care.
4. \$ 75.00 additional for services on Holidays and weekends.

b. Non-Resident Infant:

1. \$150.00 per lot.
2. \$100.00 per opening and closing.
3. \$100.00 perpetual care.
4. \$ 75.00 additional for services on Holidays and weekends.

c. Resident Adult:

1. \$250.00 per lot.
2. \$150.00 per opening and closing.
3. \$100.00 for perpetual care.

4. \$100.00 additional for services on Holidays and weekends.

d. Non-Resident Adult:

1. \$375.00 per lot.
2. \$150.00 per opening and closing.
3. \$100.00 for perpetual care.
4. \$100.00 additional for services on Holidays and weekends.

e. Cremains Or Multiple Burials On A Lot:

1. After first obtaining the prior written consent of the owner of any lot cremains may be interred on the same lot subsequent of the interment use of the full lot. A charge of \$50.00 for perpetual care shall be assessed.
2. \$85.00 per opening and closing.
3. \$40.00 additional for services on Holidays and weekends.

f. The Town reserves the right to limit multiple use of lots.

This resolution was enacted by the Board of Trustees at its regular meeting held the 28th day of June, 1988.
