5. Discussion

A. Kristina Kachur and Jeremy Call of Logan Simpson: Open Space Master Plan Review

Kristina presented an overview of a draft of the Berthoud Open Space Master Plan developed by Logan Simpson. She requested that members of the PORT committee review the document and offer comments within the two weeks following the June meeting. It is available online to review and comment at:

PDF. This allows for others to see your comments and you to add on to others. You'll need to input your name once (then it will be remembered) so we can track and respond to comments efficiently. She mentioned that the plan focuses on Natural Areas, Agriculture, and Regional Trail Corridors. The focus areas align with the town's draft Comprehensive which can be reviewed at <https://www.surveymonkey.com/r/berthoud-comp-plan-review>. Kristina also requested any pictures of town features that members of the PORT committee were willing to share.

B. Ellen Bunyan Bein Park - Fitness Obstacle Course

Keith presented an overview of the new obstacle course features that will replace the fitness equipment at Bein Park. He also noted that rubber mulch is more than 10 times as expensive as bark mulch. The budget for the project will span two years and installation of the first features will take place in a few months.

6. Staff updates – Parks, Open Space, Recreation, Trails

Keith brought the following items to the committee's attention:

- i. Installation of the batting cages at Bein park has begun.
- ii. The drainage at Hillsdale should be addressed within a few weeks.
- iii. The Fickel Park restroom project is out for bid.
- iv. The bench at the Town Park Pickleball court has been removed.

7. Committee updates

Vice chair Klein commented that FCI and Logan Simpson seemed to be doing a great job and suggested that whoever in the town connected with these organizations deserved some kudos.

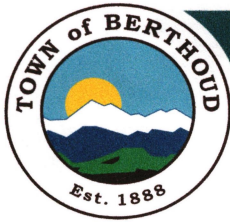
Trustee Liason Hindman echoed Phil Klein's comments and urged the committee members to offer input on the Open Space Plan and the Comprehensive Plan.
