- A. Phil proposed moving the meeting times to 6:15 moving forward
 - i. PORT Committee agrees with this time
- B. Berthoud Recreation Center: Amanda Gustafson, Director of Recreation and Cultural Service
 - i. 7 new full-time positions have started
 - ii. Hours of operation have been finalized, but the pool hours may not align with the hours of operation.
 - iii. Childcare hours will also be shorter than operation hours
 - iv. Reserving the gym past closing today is an option with a reservation
 - v. Pool will have different features open depending on the time of day
 - vi. Rec Center rates in range with other rec centers in Northern Colorado and includes child care
 - vii. Annual, monthly, daily rates available-Staff members will be offered a discounted rate and there are no residential rates with the exception of certain programs
 - viii. Berthoud is on the waiting list for Silver Sneakers
 - ix. Programming-Aquatics which includes swim lessons, fitness classes, and Lifeguard Training—Sports, 50+Programming, Special Events-Kids Night Out, Swim-in movies
 - x. Fitness Fees-free-or \$7-\$9 Fees, Personal fitness available for private or small group sessions
 - xi. Timeline-Soft opening November 17th, Nov. 20th Grand Opening (free admission day), 4 sessions for the pool on this day

- Goal is \$430,000 in membership fees
- Need a year to know operating cost
- Pool may be impacted by lifeguard shortage
Courts will be occupied for recreational sports at times, but school facilities will still be used
