*As a condition for the issuance of a Stormwater Quality Permit, applicants shall be required to provide security in the form of cash escrow or an irrevocable letter of credit. The amount of the security shall be based upon the cost of the work required to ensure compliance with the permit's terms and conditions. The security shall be released upon the Town's determination that the Permittee has successfully completed all work required by the permit. If the Permittee does not successfully complete all required work or violates any requirement of the permit, the Town may take corrective measures and charge the cost of such to the Permittee. Such costs shall include the actual cost of any work deemed necessary by the Town plus administrative and inspection costs and penalties pursuant to the city's stormwater quality enforcement policy. Please note that eligibility for a full release is determined by adequate permanent stormwater quality control features, including established vegetation. In most cases, a minimum of one year from the date of seeding is necessary to determine vegetation establishment.*
