General Information: Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained by visiting the Environmental Protection Agency (EPA) Safe Drinking Water at epa.gov/ground-water-and-drinking-water or calling the Hotline at 1-800-426-479. Some people may be more vulnerable to contaminants in drinking water than the general population and should seek advice from their health care provider. Immunocompromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV-AIDS or other immune system disorders, some elderly, and infants can be particularly at risk of infections.

Sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- **Microbial contaminants:** viruses and bacteria that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- **Inorganic contaminants:** salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- **Pesticides and herbicides:** may come from a variety of sources, such as agriculture, urban storm water runoff, and residential uses.
- **Radioactive contaminants:** can be naturally occurring or be the result of oil and gas production and mining activities.
- **Organic chemical contaminants:** including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and also may come from gas stations, urban storm water runoff, and septic systems.

To ensure tap water is safe to drink, Colorado Department of Public Health and Environment prescribes regulations limiting the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Lead in Drinking Water:

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes.

You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. If you are concerned about lead in your water and wish to have your water tested, contact Ken Matthews at 970-532-3754. Service Line Inventory:

New state and federal laws require us to inventory all water service lines in our service area to classify the material. A service line is the underground pipe that carries water from the water main, likely in the street, into your home or building. The Town of Berthoud has completed the initial service line inventory and is working with WSP to determine if there are any lead service lines or service connections within the system. If you would like to view a copy of our service line inventory or have questions about the material of your service line, contact KEN MATTHEWS at 970-532-3754.

Source Water Assessment and Protection (SWAP):

Colorado Department of Public Health and Environment may have provided us with a SWAP Report for our water supply. Visit wqcdcompliance.com/CCR for general information or to obtain a copy of the report. The report is located under "Guidance: Source Water Assessment Reports". Search the table using our system name or ID, or by contacting 970-532-3754. The SWAP Report provides a screening-level evaluation of potential contamination that could occur. It does not mean that the contamination has or will occur. We can use this information to evaluate the need to improve our current water treatment capabilities and prepare for future contamination threats. This helps us ensure that quality finished water is delivered to your homes. In addition, the source water assessment results provide a starting point for developing a source water protection plan. Potential sources of contamination in our source water area are listed on the next page.

Terms and Abbreviations

Maximum Contaminant Level (MCL): The highest level of a contaminant allowed in drinking water.

Treatment Technique (TT): Required process intended to reduce the contaminant level in drinking water.

Health-Based: A violation of either a MCL or TT.

Non-Health-Based: A violation that is not a MCL or TT.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment and other regulatory requirements.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant, below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Violation (No Abbreviation): Failure to meet a Colorado Primary Drinking Water Regulation.

Formal Enforcement Action (No Abbreviation): Escalated action taken by the State (due to the risk to public health, or number or severity of violations) to bring a non-compliant water system back into compliance.

Variance and Exemptions (V/E): Department permission not to meet a MCL or treatment technique under certain conditions.

Detected Contaminants: BERTHOUD TOWN OF routinely monitors for contaminants in your drinking water according to Federal and State laws. The following table(s) show all detections found in the period of January 1 to December 31, 2024 unless otherwise noted. The State of Colorado requires us to monitor certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. Therefore, some of our data, though representative, may be more than one-year-old. Violations and Formal Enforcement Actions, if any, are reported in the next section of this report.

Note: Only detected contaminants sampled within the last 5 years appear in this report. If no tables appear in this section, then no contaminants were detected in the last round of monitoring.

Additional Violation Information

Describe the steps taken to resolve the violation(s), and the anticipated resolution date: The M612 Backflow Prevention violation is a result of an inadequate backflow prevention and cross-connection control program. Uncontrolled cross connections can lead to inadvertent contamination of the drinking water. The inadequate survey ratio of non-single family residential connections. Surveys of non-single family residential connections are used to identify potential cross connection hazards. Surveys were previously completed, however during transitions in staffing many records were lost. The Town is completing and verifying survey information of all non-single family residential connections and is in the process of resolving this violation. Since the issuance of the initial violation the Town has identified and verified over 400 service connections that were previously missing or contained inadequate records. During this process the Town has also updated the records of over 300 backflow protection assemblies that were previously unknown or lost. Once all non-single family residential connection survey information is completed and reviewed by CDPHE this violation will be resolved.

Backflow and Cross-Connection

We have an inadequate backflow prevention and cross-connection control program. Uncontrolled cross connections can lead to inadvertent contamination of the drinking water.

We experienced a backflow contamination event. In June 2024 there was a backflow event that occurred in the Gateway Park subdivision. This was a result of an illegal cross connection between the non-potable irrigation system and the Town's potable water system. Upon discovery, the illegal cross connection was removed and all homes in the Gateway Park subdivision were inspected to confirm there were no other illegal cross connections.
