3. Larimer County Community Update

(Commissioner Donnelly)

Commissioner Donnelly: The road work being done on County Road 17 also known as Berthoud Parkway is a collaborative project between the Town and Larimer County. It is a \$5 million dollar project. About \$2.8 million of that came from grants and through a competitive process of the North Front Range Metropolitan Planning Organization. Mayor Karspeck and Commissioner Donnelly both serve on that body together. This project will be nice for the regional travel in the area and will enhance a lot of what is happening on the North side of Berthoud.

He feels that this shows the great relationship Larimer County and Berthoud have shared over the years. Larimer County works on Public Health responses to the pandemic, wildfire suppression, elections and other pressing issues that face our communities today. The Community Report Breaks things down into smaller bits of information and shows what County Government does.

4. House of Neighborly Service Presentation

(Jinger Tomassi)

Jinger Tomassi introduced Glorie Magrum Executive Director to speak. House of Neighborly Service has been serving Berthoud for thirty-years. They are there to help the community receive a hand up. A Life Center (Also known as House of Neighborly Service or HNS) allows more resources to be readily accessible to all who live in Berthoud. They have volunteers contribute their time and talents to helping others. They are asking for the donation of the Old Town Hall property for the Life Center and House of Neighborly Service as the steward.

5. Draft 2021 Budget Presentation

(Chris Kirk)

On October 13, 2020, the first draft of the 2021 Town of Berthoud Budget was provided to the Board for review. Since that time, that draft has been refined by Staff. Additionally, revenue forecasts have been updated to reflect more recent data. The draft budget reflects what the Town Board's priorities are.

It is important to note that despite the impacts of the COVID-19 pandemic, the Town is in good fiscal health. With projected revenues and reserves, the Town can continue funding all our existing services while continuing increased services in our Parks, Community Development, Admin, Police and Public Works Departments. We can also perform needed road maintenance, replace and enhance sidewalks, and construct major new capital assets.

Town Administrator Kirk turned it over to Finance Director Leach to go over the Town's Revenue, then took it back to finish the presentation.

The Board reviewed the preliminary 2021 budget and directed staff to bring the budget back to the Board on December 8, 2020 with adding numbers for a restroom at Fickel Park, instead of having the porta potty.

6. Discussion of Possible Development Code Amendments

(Mayor Pro Tem Dower)
