1. **Consent Agenda** (Christian Samora)

2. **Southern Water Supply Pipeline II Contract** (Paul Zilis)

Paul Zilis introduced the item and provided maps of our water supply.

The Board made several comments and asked several questions for a better understanding of the item for consideration.

Trustee Tomassi motioned to approve the SWSP I Reimbursement Agreement and SWSP II Contract for Capacity as presented and authorize the Town Administrator to execute the contracts. Trustee Dower seconded the motion. With all in favor, THE MOTION CARRIED.

### **3. Citizen Appointment to Tree Committee**

(Jeremy Olinger)

Gave an introduction and provided background information.

**Trustee Tomassi motioned to approve the appointment of Laura Davis to the Tree Committee. Trustee Hardy seconded the motion. With all in favor, THE MOTION CARRIED.**

### **4. Berthoud Fire Impact Fee (Informational)**

Chris Kirk introduced the impact fee.

Chief Steve Charles gave a presentation and to answer questions. This was to inform the Board what the impact fee is this included a study that was done by a 3<sup>rd</sup> party consultant Carson Bise from Bethesda, MD. The only way they can collect impact fees is through an intergovernmental partnership. Also, to explain where the fire department is located and how it effects insurance on homeowners based on the coverage area. John Camille there is a CPI that is good for seven years this address the rising cost from year to year.

**Pro-Tem Hindman motioned to approve the Intergovernmental Agreement to be effective in 30 days and subject to any non-substantive changes that the Town Administrator or Town Attorney may have. Trustee Tomassi seconded the motion. With all in favor, THE MOTION CARRIED.**

### **International Fire Code Introduction (Informational)**

Chris Kirk gave an introduction and provided background information.

### **5. Retail Marijuana Regulations & Excise Tax (1<sup>ST</sup> Reading)**

(Chris Kirk)

First of Ordinances 1242 and 1243 adopting retail marijuana authorizations and regulations as part of the Berthoud Municipal Code and imposing an excise tax in the form of a transactions fee on the retail sale of marijuana products pursuant to voter approval of such taxes at the November 7, 2017 General Election and providing specific purposes for revenue generated.

Chris Kirk gave introduction and provided background information.

The items will be brought back at the May 22, 2018 Meeting for approval.

review.


Trustee Alaback: Alaback stated that he would like to talk about what our priorities should be.


