PROTECT YOUR TREES FROM EAB

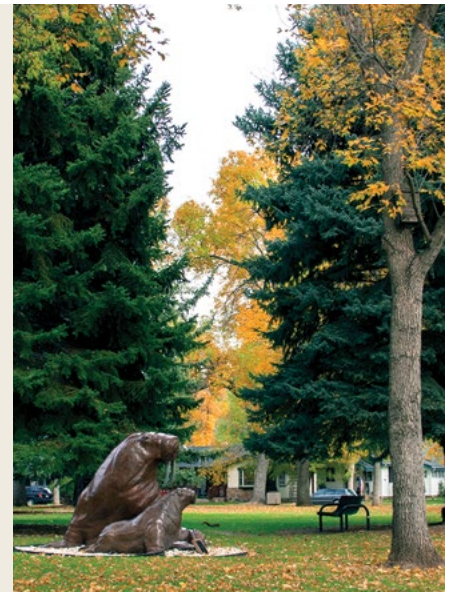
Emerald Ash Borer (EAB) hasn't hit Berthoud yet. However, the Town is taking precautionary measures of removing and treating the Town-owned Ash trees. In addition, we're recommending that you don't plant Ash trees on your own property and, if possible, remove any Ash tree that is less than 15" in diameter.

EAB is a highly destructive, non-native invasive beetle responsible for killing more than 100 million ash trees throughout the United States. Learn more about the Town's efforts to manage EAB at Berthoud.org/eab.



GET THE APP!

To help Colorado property owners determine whether their trees are susceptible to EAB, Colorado State Forest Service along with Colorado State University Extension is offering a free app that quickly determines potential threats. Search "ash tree" in the app store.
