## A COMMUNITY WITH CHARACTER: NOW AND IN THE FUTURE

The qualities that make Berthoud attractive to residential and business development are the very same characteristics that have made Berthoud unique and desirable to longtime residents.

In addition to our small-town charm and central location, Berthoud's business friendly environment and water availability are now being recognized by businesses looking for their next development opportunity.

### SUPPORTING LOCAL BUSINESS

In 2017, 14 new businesses decided to make Berthoud their home, creating an additional 50 jobs. In addition, Town staff received more than 50 inquires for site and building information, hosted 15 company tours and conducted presentation about our community throughout the region.

At the same time, limited play began on the TPC Colorado at Heron Lakes golf course, Love's Travel Center began construction, staff processed over 400 permits and we leased out the old Town Hall to four new Berthoud businesses.

### COMMUNITY INVESTMENT

A lot of work has also gone into making Berthoud a desirable location that is able to accommodate this new development. To meet these new demands on our infrastructure, the Town of Berthoud Community Development and Public Works Departments have been diligent in preparing for the future.

For example, the Development Code was updated to reflect current design and



regulatory standards. The permitting process was streamlined to increase efficiency, while maintaining the Town's commitment to quality.

Additionally, investments were made to enlarge and modernize our water and wastewater treatment plants. Capacity for water storage increased with recent enhancements to Berthoud Reservoir and improvements began on the Berthoud Parkway (CR 17).

The Town of Berthoud will continue to proactively prepare for the future with steadfast commitment to keeping Berthoud a special place.

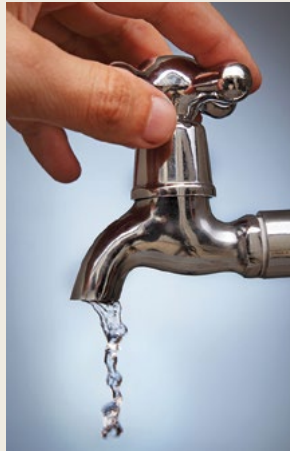


## BACKFLOW PREVENTION DEVICE TESTING

We take our drinking water quality seriously, and as such the Town of Berthoud is committed to following the adopted laws and regulations established by the State of Colorado, including the provision that prohibits hazardous connections to our drinking water supply.

That means that all non-single-family residential (i.e., all commercial and multi-family properties) connections to Berthoud's public water system need to have their Backflow Prevention Device tested yearly by a certified professional. The backflow device test reports should be delivered to the Town of Berthoud Water Department directly from the accredited technician so that we can document compliance.
